K to GRADE 8 LUNCH DUTY OBLIGATION

Lunch duty is an important, supervisory obligation for the every school family from grades k to 8. Every family is expected to supervise approximately ten lunch periods **OR pay a \$400 buyout fee.** A fine of \$50 will be levied for **EVERY DAY of MISSED LUNCH DUTY.** After 2 MISSED lunch duties, the fine will be \$100.

PRE-K to GRADE 8 VOLUNTEER OBLIGATION

Every family is expected to share their time and talents with the school community through volunteer service activities. It is estimated that an average of **25 hours per family of volunteer time, IN ADDITION TO Basket Bonanza, lunch duty, or new programs,** is necessary. Volunteer requirements will be scheduled in September.

PRE-K to GRADE 8 SAINT PATRICK SCHOOL ENDOWMENT FUND

The Endowment Fund is a permanent capital school fund established for the sole and exclusive benefit of Saint Patrick School. The fund contributes annually to support the operation and maintenance of the school. The fund's current balance is approximately \$900,000. There is normally one fundraising event per year dedicated to the fund but gifts are accepted and encouraged at any time. Checks should be made payable to Saint Patrick School and designated specifically for the Endowment Fund.
